

A regular meeting of the Board of Aldermen was held Wednesday, March 15, 2023, at 7:35 p.m. in the aldermanic chamber.

President Lori Wilshire presided; City Clerk Dan Healey recorded.

Prayer was offered by City Clerk Dan Healey; Alderman-at-Large Michael B. O'Brien, Sr., led in the Pledge to the Flag.

REMARKS BY THE MAYOR

Mayor Donchess

Yes Madam President. First I'd like to reiterate what we announced Monday which is that the NH Community Power of which Nashua Community Power is a part was able to purchase electricity for Nashua consumers and the consumers in nine other communities this past week. They were able to achieve for Nashua consumers going forward a price of 15.8 cents per kilowatt hour. This represents a 22% savings below the cost currently being paid by Nashua consumers with Eversource which is something over 20 cents per kilowatt hour. So this will save our consumers a lot of money. Maybe around \$25.00 per month as we move forward. Now this will begin implementation in May. My understanding is that after a certain date late in April, all bills paid after that date will be at the old rate but then once that final Eversource rate bill is paid, the new rate will kick in for the following bill - the May bill and then beyond.

Now this is due to the work of a lot of people. First, I want to thank the Board of Aldermen who were able to consider this and authorize the City to enter this arrangement. You worked very hard on this and took it up quickly and certainly we owe you a thank you. Also, our Aggregation Committee. A group of people who studied this, made recommendation to you regarding the approach we should take, and finally our staff lead by Doria Brown the Energy Manager, but also Deb Chisholm who's head of our Sustainability Department, and Matt Sullivan who is of course Community Development Director. They also worked hard on this over a long period of time. So I think it's a great accomplishment for the community as a whole and due to the input, the efforts of many people.

Second Madam President, I did want to mention that we have the paving contract for this year's streets on the paving plan of action coming before us. I think Mark Saunders one of the City Engineers is here. He's principally involved in supervising the paving. I hope you will approve that so we can move forward and pave streets in all of the Wards if you look at the list.

Finally Madam President, you will see on the agenda is the appointment of Liz Hannum as Economic Development Director. She's originally from New England here currently working in Oregon. She will be here to be interviewed at the next meeting of the Personnel Committee which I believe will take place April 3rd, the first Monday in April. I think you will find her to be someone who can make a great contribution to our City. That is all I have Madam President.

Thank you, Madam President. I just wanted to say thank you to everybody that was able to put this Nashua Community Power together. Being an employee of Eversource, I know what these bills are, and what the prices are, and 15 cents or 15.8 cents per kilowatt hour is a fantastic rate. I have a third-party supplier and its 16+ cents per kilowatt hours. I will be switching myself. So anybody who has a third-party supplier that's paying more than that will be able to switch. They won't automatically be switched. They'll have to switch themselves so just want to make sure people know that because everybody else who is on Eversource will automatically switch. So thank you.

Thank you, Madam President. I was going to hold this remark to the end but as we've been talking about the Nashua Community Power, I agree with what my colleague had to say about switching over and that the letters will be going out. There is a slight caveat to that and those that have solar panels and are doing the buy-back. There's a little wrinkle with that one. Eversource is not being quite cooperative as we would like them to be. If they do switch over, they won't be getting a return on their solar panels so they won't be able to qualify for it. I just want to put that out there. The Aggregate Committee and all the people that were mentioned before have done a phenomenal job and I want to thank them as well.

PERIOD FOR PUBLIC COMMENT RELATIVE TO ITEMS EXPECTED TO BE ACTED UPON THIS EVENING

Kevin Rourke, Police Chief

Good evening. Thank you for allowing me to speak tonight. I would like to speak on behalf of the Collective Bargain Agreement between the Nashua Police Commissioners and the Communications Union. The Police Commissioners and I are in favor of this contract. I think it is very fair. The members of this Union are a vital part of our Police Department. They are the first group of people who you speak to when you contact the Police Department. They have a very stressful and difficult job. They are some of the people who keep our officers safe on the street. The Union at full staff is made up of 21 members. At this time, we have 10. One would ask why that is. In my opinion, I think they are under paid. The schedule is not appealing. It's a four days on, two days off, weekends and holidays. It's a tough, demanding, and very stressful, and the job market at this time is very good.

I just want to compare the probationary employee for dispatch with other local agencies in the area. Right now in Nashua, communications or dispatchers starting out in probation would make \$49,441. Hudson PD is at \$45,281 and NFR is at \$53,776. I'll jump ahead to a 10-year employee. Nashua PD employee would make \$53,570. Hudson PD they're at \$61,193 and NFR dispatcher is at \$67,389. Our starting employee in Communications if you don't know - we have a unique situation at the Police Department where we have people answering phones. They gather the information and then relay that to our dispatchers who dispatch to our officers. Our communications personnel starts out at \$18.82/hour for a total of \$39,145 a year. Some of these local businesses in the area of Dunkin Donuts, Target, Home Depot...

You can make more money going there at this time.

Recently, I really learned from Portsmouth PD they're at 50% staffing issue right now where right now they've farmed out their dispatch to Rockingham County Sherriff's. They don't even have coverage to cover that. That is not a place I want to go. Right now we have our officers filling in overtime shifts to cover dispatch and communications and at that point it can become costly for us. So we're looking to get the full staff. Tonight I just ask for your continued support and pass this contract. Thank you.

Boy that's a fine line between a mandate and then give this enough teeth to cause a good outcome. I always look at a legislation the way I evaluate it as what is the outcome that you want from this? If I were to look at Nashua in 25 years and it's more environmentally friendly (which I hope it is), I don't know if it's because of this legislation. I don't know if it endures enough beyond this Board. Because of the fact that there is a lot of nebulous and ambiguous language in it. For instance in point two, you use the word "consult". I mean consult and even in the Committee meeting, there was some back and forth on what one word meant to one Alderman and what it meant to somebody else.

I would just like to it be a little bit more specific. What's interesting is you spoke to point five. Point five was the one I liked most out of the five because it was specific. It was measurable. There was a course of action there to take. The other four points I think just need some work. In this case, I'm not going to support it tonight. Thanks.

President Wilshire

Alderman Klee?

Alderman Klee

Thank you, Madam President. Addressing some of the comments that were just made and I, too, had watched many of the meetings as well. The issue that I had with five as well as my colleague Alderman Gouveia was that it was a mandate. In this economic times where things are already coming in over budget for gas type vehicles, it would put a strain on the taxpayer to ask them to have to come up with electric and alternative type of fuels. I applaud the Committee for suggesting that.

One of the comments that came out of the last meeting was relative to when something gets brought to the Finance

Committee that it gets brought to them with basically this is what it would cost if we got a gas vehicle. This is what it would cost if we got an alternative whether it be hybrid, or so on, and that cost would include the lifetime cost of it. So the taxpayer and in general, we could see that maybe we're saving enough money but the truth is, we have a spending cap and so on which may preclude us from spending that extra money up front. That may say no we can't do it because if we do that than we can't do something else. So I'm glad that they put that we're going to look at it as an alternative. I think that's very important and the spending cap does dictate what we can and what we should do and so on.

I'm glad when I saw that they will have consulting for sustainability. A comment was made at the last meeting, the Personnel meeting, relative to that we have these buildings and no one consulted to see if we could do some more energy efficiency. I corrected the record to say that discussions had happened. They had in fact happened. They may not have had that conversation with this Committee and maybe they should have but those conversations were happening. So I'm glad that this consulting was put in there. They're not going to be able to make the determination but it's good to get input and that's the way I look at consulting. I will be supporting this with that change and I appreciate all the effort that Alderwoman Kelly went to make that change and was listening to my comments so thank you.

President Wilshire

Alderman O'Brien?

Alderman O'Brien

Thank you, Madam President. First I want to thank the Committee. This is definitely a step in the right direction but I see it as guideline not really to be the right way. So let's keep it in that particular context. Like I saw in number three, I see creating sidewalk corridors. There are issues. We're hearing them now in our emails who's going to plow them because of that Supreme Court ruling. They also too is bike lanes on all main streets. Well that impedes traffic and that could cut down a lane. Just look at Cambridge, MA.

And then number five, I think it's a great idea to have charging stations at all municipal buildings as long as the people who are charging are going to pay for it and it's not clearly defined. So I consider it a work in progress but it's not enough for me to stop this. Therefore, I'm going to support it with or whether I to keep this going in the future.

President Wilshire

Alderman Lopez?

Alderman Lopez

I appreciated the discussion too. I watched it on YouTube as well as many members of the public. I had fun with number five as well. Interesting that that's the one that Alderman Sullivan appreciates the most. I was like is the bike shed over by the Leighton House going to get a charging station or the dugouts? But it is a Resolution. It's a step forward. It's not like we're never going to revise this before now and 2030. That's not how politics works. I think this is a very good step forward. I think it was very well vetted and can we come up with all kinds of extraneous examples of how it could be misunderstood? Sure but that's the point of being able to continue it as a living document. So I will support this and I think it's a great initiative.

President Wilshire

Alderman Jette?

Alderman Jette

Thank you, Madam President. So I think this is aspirational. I appreciate Alderman Sullivan's criticism that it doesn't have the sufficient teeth. I kind of agree with him but doing nothing I think is worse. I think the City has in the past declared its intention to get away from fossil fuels, to become more energy efficient, and yet I think there have been examples of where we have undertaken projects, and made decisions that were at variance with that. I'm hoping that even though this really isn't a mandate, it is aspirational that we Aldermen, and the City staff, and Board of Public Works, the School Department, that everybody takes this seriously and joins us in wanting to move towards a more energy efficient future. Climate change is real and we have to get away from burning fossil fuels. So I support this because it's a step in the right direction. I wish I went further. I wish there were more teeth to it but maybe down the road we can tighten it up a bit as we go along but I will support this tonight.

President Wilshire

Alderman Clemons?

Alderman Clemons

Thank you. I want to commend the Environment and Energy Committee for coming up with these recommendations and for Alderwoman Kelly for bringing this forward. In particular, the amendment because it allows me to be able to support this legislation the amendment does because I, too, had the concerns about point number five.

More to the point though, I think it's always important to support aspirational things particularly when they come from a working group of citizens who come together and employees of the city who come together and work hard and put their efforts into this. A lot of different things were studied and a lot of different areas were worked on. I think these are all aspirational goals that will make Nashua a better place to live 10, 15, 20 years from now. So even if there's no teeth behind this, for me I'm always going to support a better future for Nashua. This is a roadmap to try to get there. Whether we can do it or not remains to be seen. It's going to be decisions that happen here at this Board level but this is a pretty good roadmap to try to move forward. It's going to make our city better and I'm going to support it.

President Wilshire

Alderman Comeau?

Alderman Comeau

Yes thank you, Madam President. Like my colleague from Ward 9, I generally have a hard time with mandates. But that being said, I don't view this as meeting my criteria for a mandate. The language that I find key here is that it says that we're going to adopt the following goals. If this said we're going to do these things, I might have a bigger problem with it but where this is a list of goals that we're going to try to aspire to, and there's no penalty for non-compliance, or this is not something that's going to tie our hands in the future, I don't have nearly as much of a problem with it as I would if it was something that was mandating certain actions. So as a roadmap and as a list of goals, I think it's a good list. I think these are all things we should be doing and that being said, I will support this this evening. Thank you.

President Wilshire

Alderman Dowd?

Alderman Dowd

Yes. I think this is a good first step in the right direction. When it comes to charging stations, it hasn't been approved by the Joint Special yet but we're going to put the infrastructure in. If it's approved at the new middle school to have the infrastructure to put ten charging stations in - we're not at the point where we're gonna buy the charging stations but we don't want to be digging up brand new parking lots and median strips later to put in charging stations. It's far more expensive. Very easy now if we put a conduit in underneath that can handle the infrastructure for the charging stations. That will be up to the Joint Special.

That being said, I've had discussions with DPW and the Fire Department on this and they would prefer on item five before the first sentence "where feasible" because right now large vehicles, plows, and other large vehicles, it's not feasible. So rather than go through all kinds of iteration and work when it's not feasible, and I think that could be worked into the CERF program, and when they are feasible downstream, maybe. Like fire trucks, it's very difficult for firefighters especially large ones to be electric because when they go to a fire, they have to keep running. They're pumping water and things. How'd you like they have your house on fire and all of a sudden there's no water because the electric vehicle wasn't pumping anymore. These are the types of things that need to be thought about. So I'm going to make a motion to further amend this item five, paragraph five to add before the first sentence "where feasible".

Is that your Motion?

Alderman Dowd

That's the motion.

President Wilshire

Motion has been made. Alderman Clemons?

Alderman Clemons

Well much like the federalists said about the Bill of Rights, they didn't think it was necessary but I'm going to agree to put it in there. I don't think it will harm this. I don't think it's necessary necessarily but I'm not going to not support it either because I think what you said makes sense so.

President Wilshire

Further discussion on the amendment? Alderman Jette?

Alderman Jette

Through you Madam President could I ask the maker of the motion where is the word "feasible" going to be placed here?

Alderman Dowd

It's two words – "where feasible" and it would be added before the first word "evaluate" in paragraph 5, the first paragraph. So it would start off "Where feasible, evaluate alternatives". There's no sense going through all the iterations of going through CERF and everywhere else to evaluate something that's not feasible.

Alderman Jette

Could I follow up?

President Wilshire

Yup.

Alderman Jette

So "where feasible" would modify evaluate?

Alderman Dowd

"Where feasible, evaluate". So if it's not feasible, you're not going to go through this whole evaluation process, and through CERF, and everybody else to come up with the answer that you know ahead of time. It's not feasible.

Alderman Jette

Could I?

President Wilshire

Alderman Jette?

Alderman Jette

So by "where feasible" if it modifies evaluate, you're saying that the evaluation process. You're saying where it's feasible to do an evaluation. I think what you want to say is that when you evaluate these things, you're not going to buy a fire engine if it's not feasible but that's part of the evaluation process. All this does is say evaluate alternative fuel vehicles during the replacement process by comparing electric or hybrid models to the traditional vehicle options at the purchasing

step. So if during the evaluation process it comes out that - for example your example of a fire engine that that's not practical. Well then it would not be adopted because it's not practical. To eliminate it before you even evaluate it doesn't make sense to me. It seems you evaluate it if - who knows in ten years they may have electric fire engines that are capable of doing what you say. You won't know that until you evaluate it.

Alderman Dowd

Then it would be feasible and you'd know that up front. Why go through a whole evaluation process if you already know the answer, it's not feasible. They don't have electric fire trucks.

Alderman Klee

Yes they do.

Alderman Dowd

I mean what its saying is it's not feasible, you don't go through this evaluation process to come up with an answer you already know.

Alderman Jette

May I?

President Wilshire

Alderman Jette?

Alderman Jette

I'm just saying that you won't know if it's feasible or not until you evaluate it. You can't go into these things already knowing what you think is the answer. This is the problem that we've been having. People approach these problems thinking that they already know the answer. So they just reject out of hand the possibility of doing something different. They stick with what they've done for years, and years, and years because they know that works. That it's dependable and I understand that but you're not going to appreciate the possibility of new technology unless you evaluate it. So I can't support what you're suggesting.

Alderman Dowd

What I'm saying is if the DPW or the Fire Department goes out there and they know right ahead of time that there's nothing available and the technology is not there yet, you don't need to go into this big long evaluation process and have written documents and hours of conversation when you know what the answer is.

Alderman Moran

Point of order. I just have a point of order. Wouldn't it just make sense to ask Attorney Bolton so we don't go back and forth? I know we have an attorney right here but it might just make sense to get Corporation Counsel's opinion.

Steve Bolton, Corporation Counsel

I think it might capture what all Alderman Dowd is suggesting. If instead of including "where feasible" before evaluate to insert after the word vehicles "if such alternatives exist".

Alderman Dowd

I would be willing to change my terminology on my motion to amend to what was just brought up by Attorney Bolton.

President Wilshire

Okay, I'm going to call on Alderwoman Kelly.

Alderwoman Kelly

I actually am now amenable to what the original (inaudible) have suggested because I have similar concerns as Alderman Jette that where feasible leaves it open to what's feasible. I don't have time to do the evaluation. I don't, you know, like as technology goes along feasible can be kind of a squishy word so I do like the recommendation and I'm happy to support that.

Alderman Sullivan

Thank you. This resolution passed unanimously in the Budget Committee a week ago. Our Chief of Police both spoke eloquently to the changes that we made in this contract which I think do a fantastic job of trying to catch up to neighboring communities to try to fill the ranks of the folks on the front line and that are taking calls. Very stressful job. I think that one thing that that's lost besides the salaries that we pay these folks are the benefits. While there are comparisons to some private employers that were made, City employees have a very generous health care plan. I think that we should look at the entire package that we offer our City employees. I think it's very generous and I think that is something, you know, if we were to market the City or why would I take this role, I think that we should not leave that to the side, I think we should include that. So I will be supporting this tonight. Thank you.

Alderman Clemons?

Alderman Clemons

Thank you. I have been a strong supporter of our Police Department. I've been a strong supporter of this particular Union in the past and I will support this tonight and encourage all of my colleagues to support it as well.

President Wilshire

Alderwoman Kelly?

Alderwoman Kelly

I just wanted to echo my full support of this contract. I think it's really important. I wanted to just point out the appreciative that Chief Rourke came forward and talked a little bit about their struggles with staffing this group. I think they're a very

important group and a lot of his patrolmen are doing overtime. So I'd love to continue those conversations and see how it's further helped that issue in the future because they needed good people in these roles. Thank you.

Alderman Comeau?

Alderman Comeau

Yes thank you Madam President. I'd like to echo the sentiments from the previous speakers. I also have been a big supporter of Nashua Police and all the various unions that support them. Hearing Chief Rourke earlier talk about the staffing levels, that's a scary thought. We spent some time earlier tonight talking about what happens when you let wages and benefits fall behind what can happen to your staffing. I'd hate to see, you know, what's going on with transit right now end up happen with the Police Department and hearing about neighboring towns having to call in sheriff's deputies to answer the phones is something that I hope we never have to experience. So I'm glad that this brings us up to a more competitive level and hopefully that will result in some positive recruitment and we can get our staffing levels up to have a fully functioning and effective Police Department. Thank you.

Alderman Gouveia?

Alderman Gouveia

Thank you, Madam President. I am in full support of this. Obviously staffing is a big deal. I know Alderman O'Brien and I spent a lot of time up in Concord talking to 400 individuals about recruitment and retention upon first responders. To go off of what the Chief said earlier tonight over in the Portsmouth area with them going through the County for dispatching, I deal daily with a Captain of the Portsmouth Fire Department and when that ended up happening and dispatching was going through the County, it was not a smooth transition to say the least and making sure we could keep this in house and making sure they're taken care of and we have that recruiting and retention arm is huge. So I am in full support of this. Thank you.

Alderman Thibeault?

Alderman Thibeault

Thank you, Madam President. I have spoken before about how I have police in my family. I'm pro police all the way. I've supported every resolution/ordinance that has included police, including Chief Rourke's persistence on getting two more police officers out of the escrow which I supported.

That being said, I work for Eversource and we get calls from dispatchers all the time. I'll tell you right now, it's a tough job. We've interviewed quite a few dispatchers from not just and I can't say from Nashua but from around the area even in Connecticut and they want to leave their jobs because it's tough and they can get more money elsewhere. It burns them out after a while and to be honest, I don't think this is enough but you know as we go out and we talk taxes with our constituents, and the Mayor will say and he said it eight times so far in Ward meetings, the biggest taxes come from salaries, benefits, infrastructure. So every time we go up in salaries, it hits that but I'm 100% for this. It's just people have to realize that's what it impacts and I think we pay too low on everything that's important, police, fire, teachers, you name it. So I'm for this.

President Wilshire

Alderman Lopez?

Alderman Lopez

I don't know that I've always been portrayed as supportive of the police but I would say that I always support their budgetary requests and I work very, very, very, very regularly with them coming from a Ward that has a lot of activity and a lot of constituents with different needs. I think while people who may be looking at the bottom line may not necessarily see this as dramatic as the bulletproof vests, or the new cruisers, or that type of thing, it is essential to public trust that we

have effective communication. It is essential to officer safety that we have effective dispatching in response to these types of crises. This is an area that the police has identified as something that they need to work on and they need our help to be able to address those needs.

As Alderman Comeau compared it to Nashua City Transit, I agree. We can't understaffed essential services that people rely on and where I compared it to people who rely on the bus with mobility issues for their life access, trying to get a hold of them, or trying to access their doctor's appointments or shopping, all that kind of stuff. In a crisis you don't want a shortage of people who are qualified and experienced handling it. This is something that we need to get right on top of and we need to make sure that we have the resources and the tools to support both the safety of our police officers and the interactions with our public.

I'd like to speak to it.

Alderman Klee

Thank you very much. The reason for the rush on this was last Friday I learned that the DRA had contacted the City and all municipalities, not just Nashua, and reiterated that if they did not pass this by April 1st and put it into the reauthorization I should say, by April 1st that it would revert down to the minimum of the \$50. I truly found it incredulous that this could possibly be the case. How could something like this happened over the Bill? I know the Bill HB1667 what it does is it redefines Veterans. It brings into the veteran's definition all active duty as well as the guards. It also brings in certain trainees. I shouldn't say trainees - those that went through basic training but didn't necessarily make it out. It's not something that I was in favor of. I actually the one and only time spoke on the floor of the House in my six years was to advocate against this. I lost on the floor but I think a lot of many communities are going to be feeling this especially the fact that we bring in active duty and guards that were no longer before. That's active and retired guards, guardsmen so and women.

The issue here this is a little different way back when we had the solar credit and they had changed the definition, a lot of things like that. They put a little statement at the bottom of that. This is what the DRA has told me. They had put a statement at the bottom that said there was no need to reauthorize because the passage of this was basically a reauthorization. They made a booboo when they did HB1667 and did not put that phrase in there. So it is necessary for us to do this, and get it signed, and Assessing will not be taking \$450 away from the 2,400 or so veterans that are getting it and the potential of well over three or more thousand. As the fiscal note states in here, it is impossible to really say what the overall cost or anything like that is because we don't know what the active duty and the members of the guards how many will be coming forward. So having said that, I hope that we can all unanimously reauthorize this and send the message out to the veterans that, you know, we're going to take care of this. Thank you.

As someone who authored the legislation to increase the Veteran's Tax Credit all the way up to \$750 despite my reservations about what they consider a veteran now, I am fully in support of this.
