



## ORDINANCE

### REGARDING RESOLUTIONS TO APPROVE COST ITEMS OF A COLLECTIVE BARGAINING AGREEMENT

#### *CITY OF NASHUA*

*In the Year Two Thousand and Ten*

*The City of Nashua ordains* that "Part I, Administrative Legislation", Chapter 5 "Administration of Government", Part 2 "Board of Aldermen", Article III "Rules and Order of Business", Section 5-19 "Necessary procedure for passage", of the Nashua Revised Ordinances, as amended, be hereby further amended by adding the following new underlined language:

**"§ 5-19. Necessary procedure for passage.**

...

- H. No resolution to approve the cost items of a collective bargaining agreement shall be introduced without an attached cost analysis of the collective bargaining agreement. This provision shall be waived if the cost analysis has not been completed within 21 days of the submission of the collective bargaining agreement to the office of City Solicitor/Corporation Counsel. Furthermore, all resolutions to approve the cost items of a collective bargaining agreement shall include both a marked-up copy of the collective bargaining agreement showing all additions and deletions to the agreement, as well as a clean copy of the proposed collective bargaining agreement."

This ordinance shall take effect upon passage.

All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
