**RESOLVED** by the Board of Aldermen of the City of Nashua that the Fairgrounds Middle School Student Historic Preservation Team, with the assistance of teacher advisor Mary Foran, Parks and Recreation Superintendent Nick Caggiano and his staff, and Amy Gill in the Engineering Department, be thanked and recognized for their 11 years of interest and perseverance in bringing attention to the Nashua Manufacturing Company's 1886 Gatehouse in Mine Falls Park. The result has been the completion of the Historic Preservation Study and the restoration project, allowing the Gatehouse to be opened for public viewing.

The City recognizes all student members over the past 11 years and their teacher advisor Mary Foran, for their persistence and their ability to handle this project on a grassroots level and to see it through to completion so future generations of Nashuans will understand the significance that the Gatehouse and water power played in the history and development of the city. The Gatehouse project recently received the 2009 New Hampshire Preservation Achievement Award for outstanding preservation, restoration, and rehabilitation. The work and effort put forth by the Fairgrounds Middle School Student Historic Preservation Team has given the city a historical asset that enriches our community.
