AUTHORIZING THE TRANSFER OF \$46,000 FROM ACCOUNT #674-05 "CAPITAL IMPROVEMENTS – VAN REPLACEMENT" TO ACCOUNT #553-69051 "STREET DEPARTMENT – FUEL ISLAND DISPENSERS" AND ACCOUNT #553-68056 "STREET DEPARTMENT – SIDEWALK PLOW"

In the Year Two Thousand and Nine

RESOLVED by the Board of Aldermen of the City of Nashua that

WHEREAS Resolution R-08-21-A, "Adoption of the Fiscal Year 2009 budget" authorized a capital improvement appropriation of \$170,000 to the Nashua Transit System for a 20% match to replace ADA accessible vans; and

WHEREAS the Nashua Transit System was able to purchase fewer vans than were originally estimated and have \$46,000 in funds remaining; and

WHEREAS the Division of Public Works would like to use the remaining funds towards the purchase of a sidewalk plow and two additional dual product dispensers for the fuel island at the Street Department.

NOW THEREFORE BE IT RESOLVED that the \$46,000 remaining in Account #674-05 "Capital Improvements – Van Replacement" be transferred to the following accounts:

This resolution reallocates FY09 funding in the General Fund operating budget to address other equipment needs.


Charter Sec. 53 permits the Board of Aldermen to transfer any unencumbered appropriation balance or any portion thereof from one department, fund or agency to another.


