RELATIVE TO THE ACCEPTANCE AND APPROPRIATION OF \$834,900 INTO SPECIAL REVENUE ACCOUNT # 373-7002 "FY 2010 ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT" FROM THE UNITED STATES DEPARTMENT OF ENERGY

CITY OF NASHUA

In the Year Two Thousand and Nine

RESOLVED by the Board of Aldermen of the City of Nashua that the City of Nashua and the Office of Economic Development are authorized to accept and appropriate \$834,900 of American Recovery and Reinvestment Act (ARRA) funds from the United States Department of Energy into Special Revenue Account #373-7002 "FY 2010 Energy Efficiency and Conservation Block Grant (EECBG)" for the purpose of developing a longrange plan for energy efficiency and management. These activities include, but are not limited to, municipal buildings and facilities evaluation, street lighting inventory and identification of opportunities, sustainable energy supply research, energy management goals and planning, community energy strategies development, transportation infrastructure and integrated transportation and land use strategy development; development of an energy efficiency and conservation strategy; building energy audits and retrofits, including weatherization; financial incentive programs for energy efficiency such as energy savings performance contracting, on-bill financing, and revolving loan funds; transportation programs to conserve energy; building code development, implementation, and inspections; installation of distributed energy technologies including combined heat and power and district heating and cooling systems; material conservation programs including source reduction, recycling, and recycled content procurement programs; reduction and capture of greenhouse gas emissions generated by landfills or similar waste-related sources; installation of energy efficient traffic signals and street lighting; installation of renewable energy technologies on government buildings; any other appropriate activity that meets the purposes of the program and is approved by DOE.

This funding shall be in effect from September 1, 2009 through August 31, 2012.
