RESOLVED by the Board of Aldermen of the City of Nashua that the Fiscal Year 2011 Proposed Budget for the General Fund of the City of Nashua be and is hereby adopted, and that the following amounts are hereby appropriated for the several accounts and for other needs of the City of Nashua General Fund for the fiscal year beginning July 1, 2010, and ending June 30, 2011, and for the purpose of Section 50-a et seq. of the Nashua Revised City Charter, as amended, each item of this budget shall be considered as a separate appropriation. The proposed General Fund appropriation amount is \$223,396,153 with estimated General Fund Revenues of \$27,209,344 and estimated state funding for education in the amount of \$35,998,972.

That Fiscal Year 2011 Proposed Budget for the Enterprise Funds of the City of Nashua be and is hereby adopted, and that the following amounts are hereby appropriated for the several accounts and for other needs of the City of Nashua Enterprise Funds for the fiscal year beginning July 1, 2010 and ending June 30, 2011, and the purpose of Section 50-a et seq. of the Nashua Revised City Charter, as amended, each item of this budget shall be considered as a separate appropriation. The proposed Enterprise Funds appropriation amount is \$27,462,918 (inclusive of anticipated Capital Appropriations), with estimated Enterprise Funds Revenues of \$23,534,728 and any additional funding for capital and CSO-related expenditures from retained earnings, bonding and/or State Revolving Fund Loans.

The proposed Special Funds appropriation amount is \$6,899,871 with estimated Special Revenue Funds Revenues of \$6,899,871.

Pursuant to NRO § 5-145, E., the accumulated sum of all appropriations of the FY2011 combined annual municipal budget is \$240,046,466. The FY2011 dollar amount under the limit established by City Charter Section 56-c is \$1,304,221.

Neither the approval and adoption of this budget, or any appropriation contained herein, or to any City department or agency, including the Nashua School District, whether as proposed or amended, shall be deemed to mean that the City has approved any program or responsibility for funding in accordance with Part 1, Article 28-a of the Constitution of the State of New Hampshire. Notwithstanding any appropriation herein, the city hereby expressly declines to approve funding for any program or responsibility for which it is entitled by law to payment from the State of New Hampshire pursuant to Part 1, Article 28-a of the State Constitution, whether it has previously been determined that the City is entitled to said funding or not.

FISCAL NOTE:

The tax rate cannot be determined at this time, however estimates will be provided as the impact of State budget cuts and pending State legislation becomes known. The entire budget is a comprehensive package and each component impacts the tax rate.

ANALYSIS

This resolution establishes and authorizes the Fiscal Year 2011 Proposed Budget for the General Fund of the City of Nashua for the fiscal year beginning July 1, 2010, and ending June 30, 2011. For the purpose of Section 50-a et seq. of the Nashua Revised City Charter, as amended, each item of this budget shall be considered as a separate appropriation. The proposed General Fund appropriation amount is \$223,396,153 with estimated General Fund Revenues of \$27,209,344 and estimated state funding for education in the amount of \$35,998,972. The proposed Enterprise Funds appropriation amount is \$27,462,918 (inclusive of anticipated Capital Appropriations), with estimated Enterprise Funds Revenues of \$23,534,728 and any additional funding for capital and CSO-related expenditures from retained earnings, bonding and/or State Revolving Fund Loans. The proposed Special Funds appropriation amount is \$6,899,871 with estimated Special Revenue Funds Revenues of \$6,899,871.

A public hearing on the budget shall be held before its adoption by the board of aldermen with at least seven days notice. Nashua City Charter § 56-a; NRO § 5-8.

The board of aldermen may reduce any item(s) in the budget by a majority vote, but an increase or addition requires a vote of two-thirds of the members of the board. Nashua City Charter § 56-b.

The budget shall be finally adopted not later than August 1, 2010. Nashua City Charter § 56-b.
