



## RESOLUTION

**AUTHORIZING THE TRANSFER OF \$45,000 FROM ACCOUNT 374-07990-7111  
“CDBG FY2011 CONTINGENCY” INTO ACCOUNT 374-07296-7111 “CDBG – PARKS  
AND RECREATION DEPARTMENT”**

### *CITY OF NASHUA*

*In the Year Two Thousand and Eleven*

***WHEREAS*** improvements and repairs to city parks, including but not limited to Deschenes Oval and Labine Field, are eligible uses of Community Development Block Grant (CDBG) funds; and

***WHEREAS*** a reduction in FY2012 CDBG funds received from the U.S. Department of Housing and Urban Development (HUD) has limited the funding available for improvements and repairs to city parks;

***NOW THEREFORE, BE IT RESOLVED*** by the Board of Aldermen of the City of Nashua that the FY2011 Community Development Block Grant be and hereby is amended by transferring \$45,000 from FY2011 CDBG Contingency Account 374-07990-7111 into CDBG Account 374-07296-7111 “CDBG – Parks and Recreation Department” for improvements and repairs to city parks.

**ANALYSIS**

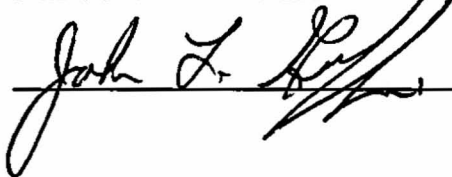
This resolution authorizes a transfer of \$45,000 from CDBG FY11 Contingency for the purpose of funding improvements and repairs to city parks.

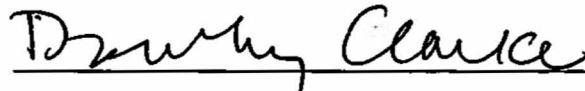
