AMENDING THE USE OF FISCAL YEAR 2011 COMMUNITY DEVELOPMENT BLOCK GRANT ("CDGB") FUNDING BY POLICE ATHLETIC LEAGUE

In the Year Two Thousand and Eleven

RESOLVED by the Board of Aldermen of the City of Nashua that

WHEREAS Resolution R-10-22 (Amended) authorized funding from the FY2011 CDBG in the amount of \$20,000 to the Police Athletic League for "installation of a kitchen and related rehabilitation at 52 Ash Street"; and

WHEREAS installation of a commercial kitchen is not financially feasible within the awarded amount and the Police Athletic League has requested these funds instead be allocated toward repairing and resurfacing the paved play area at their facility;

NOW THEREFORE the Police Athletic League is granted permission to use the \$20,000 from FY2011 Community Development Block Grant funds for the parking lot improvements described above, following the execution of an amended Subrecipient Agreement with the City.
