



RESOLUTION

RELATIVE TO FUNDING THE PLANNING STUDY FOR THE EAST HOLLIS STREET GATEWAY IMPROVEMENT PROJECT

CITY OF NASHUA

In the Year Two Thousand and Fourteen

RESOLVED by the Board of Aldermen of the City of Nashua to accept and appropriate a contribution from Renaissance Downtowns of Nashua, LLC in the amount of \$30,000 into DPW Projects Activity "East Hollis Street Gateway Improvement Project" for a planning study for the East Hollis Street Gateway Improvement project.

AND FURTHER BE IT RESOLVED that \$55,000 be transferred from Department 169 – Wastewater Fund, Accounting Classification 81 – Capital Improvements into DPW Projects Activity "East Hollis Street Gateway Improvement Project" for a planning study for the East Hollis Street Gateway Improvement project.

AND FURTHER BE IT RESOLVED that \$25,000 be transferred from Department 194, Accounting Classification 70 - Contingency into DPW Projects Activity "East Hollis Street Gateway Improvement Project" for a planning study for the East Hollis Street Gateway Improvement project.

ANALYSIS

This resolution approves the funding of the planning study for the East Hollis Street Gateway Improvement Project. \$30,000 towards the study is being contributed from Renaissance Downtowns of Nashua, LLC; \$55,000 towards the study is from the Wastewater Fund; and the remainder of \$25,000 will come from FY14 general contingency.

This planning study is directly related to R-13-154, "Authorizing the Mayor to enter into a transportation project agreement with the State of New Hampshire for the purpose of constructing a multi-lane roundabout replacing the existing signalized intersection where East Hollis Street and Canal Street meet Bridge Street and to accept and appropriate \$3,661,000 for the project", passed by the Board of Aldermen on December 23, 2013.

The wastewater portion of the study includes examining combined sewer overflow flooding that occurs on C and D Streets, the function and current use of the pump station and emergency overflow basin that is part of the levee flood control system, and reuse and treatment of stormwater.

Charter Sec. 53 permits the Board of Aldermen to transfer any unencumbered appropriation balance or any portion thereof from one department, fund or agency to another.

NRO § 5-130, H provides that "when proposed legislation to transfer or reappropriate a particular appropriation or portion thereof has had its first reading, such funds shall not be expended or transferred while the legislation is pending".
