



## RESOLUTION

### AMENDING THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ANNUAL ACTION PLAN FOR FISCAL YEAR 2024 RELATIVE TO THE COMMUNITY DEVELOPMENT BLOCK GRANT (“CDBG”)

### *CITY OF NASHUA*

*In the Year Two Thousand Twenty-Three*

**WHEREAS**, R-23-102, as amended, authorized the Mayor to file an application with the U.S. Department of Housing and Urban Development (“HUD”) for the Community Development Block Grant (“CDBG”), and the HOME Investment Partnership Program, and to execute all understandings, assurances and agreements as required therein for certain activities funded in FY 2024 (HUD Program Year 2023);

**WHEREAS**, the FY 2024 Annual Action plan did not mention incomplete prior-year CDBG projects: The City of Nashua proposes to carry forward the following CDBG activities from prior program years: FY 2023 (PY 2022) Pine Street Pedestrian Crossing Project (\$100,000); FY 2022 (PY 2021) Ash Street Futsal Court Lighting Project (\$10,000); and FY 2022 (PY 2021) Los Amigos Playground Renovations Project (\$15,000); and

**WHEREAS**, HUD required these funds to be allocated into FY 2024 activities, as these prior-year activities were not mentioned in the draft Annual Action Plan made available to the general public for review.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF NASHUA**, that the following CDBG activities shall be amended:

1. FY 2024 CDBG funds for Rental Improvements Program: Decrease funding from \$125,000 to \$0.
2. FY 2023 CDBG funds for Pine Street Pedestrian Crossing Project: Increase funds from \$0 to \$100,000.
3. FY 2022 CDBG funds for Ash Street Futsal Court Lighting Project: Increase funds from \$0 to \$10,000.
4. FY 2022 CDBG funds for Los Amigos Playground Renovations Project: Increase funds from \$0 to \$15,000.
